in this letter dated 10th July 2017 reference no F 46/AVANTAN PASCHIM (West)/2017/2253 you have rejected our application because land that we have asked for allotment is not convertible for land use as per the order of High Court.

Sir, I would like to bring to your kind notice that Ramakrishna Sewashram is a registered society and is a Non Profit Earning Charitable Institution involved in conducting charitable work in Jodhpur and around Jodhpur. The Ramakrishna Sewashram plans to increase the charitable work on much larger scale.

- I. To start educational institutions like multidisciplinary and interdisciplinary Educational Institutes and hostels for needy students
- II. To establish Medical Facilities by constructing hospitals where all the facilities including (i) Allopathy (ii) Homeopathy (iii) Ayurvedic (iv) Unani treatment will be provided at very low cost and sometimes free depending on the financial condition of the patient
- III. In this order kindly refer point no. 3 and 4. Point No. 3 Quote "Education and medical Institutions" Unquote. Point No. 4 Quote "Non Profit Earning Charitable Trust Institutions and entities which are eligible for allotment of land under state policy for allotment of land on concessional rates" Unquote. This notification is enclosed as Annexure III

Sir, I have mentioned in earlier paragraphs all about the charitable activities that are being conducted and will be conducted by Ramakrishna Sewashram Jodhpur. So, I request you that as for the point number 3 and 4 mentioned in the office order of Shri R S Shekhawat dated July 20th 2017.
